## **DESCRIPTION**

This spacious, two bedroom flat is in a popular, quiet residential area of this traditional-looking but busy Victorian seaside town.

Llandudno town centre is within easy reach, including many national retailers such as Marks and Spencer, Sainsbury, Debenhams, BHS and Asda.

The Promenade and beach are less than half a mile away, a fifth of all of Wales' hotels are within easy walking distance, so combining attractive leisure and employment opportunities.

Primary and secondary schools are all within a few minutes travel.

Transport links are good, local bus routes and the railway close by and the A55 Expressway less than five miles away.

Pets may be acceptable, but it is a 1<sup>st</sup> floor flat with no dedicated garden.

To make a pleasant and safe environment for all, the flat is non-smoking.

Heating and cooking is with electricity, and **an electric cooker is provided with the flat.**

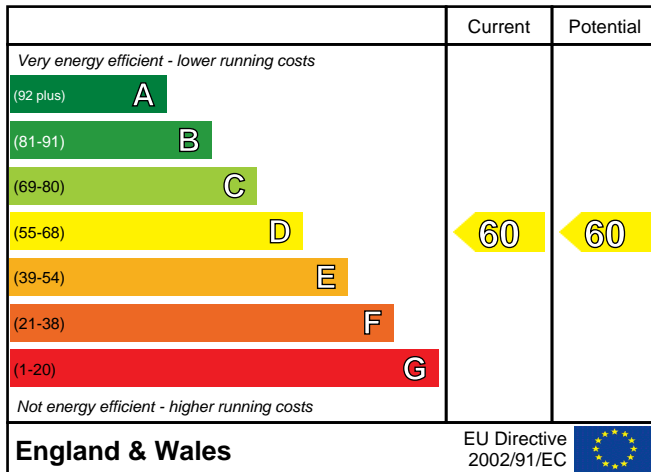

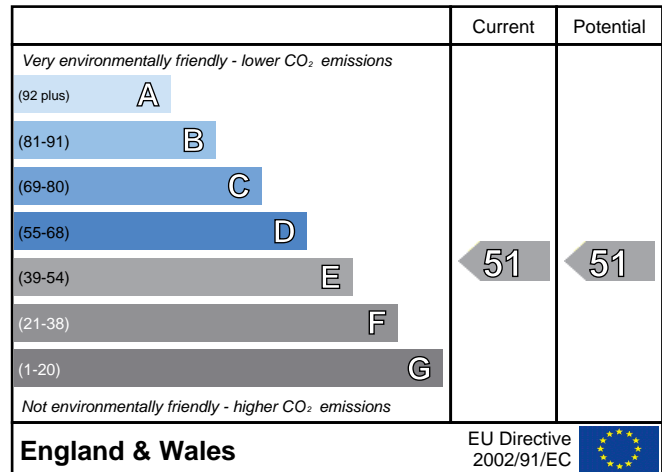

## About the building's performance ratings

The ratings on the certificate provide a measure of the building's overall energy efficiency and its environmental impact, calculated in accordance with a national methodology that takes into account factors such as insulation, heating and hot water systems, ventilation and fuels used. ## About the impact of buildings on the environment

One of the biggest contributors to global warming is carbon dioxide. The way we use energy in buildings causes emissions of carbon. The energy we use for heating, lighting and power in homes produces over a quarter of the UK's carbon dioxide emissions and other buildings produce a further one-sixth.

The average household causes about 6 tonnes of carbon dioxide every year. Adopting the recommendations in this report can reduce emissions and protect the environment. You could reduce emissions even more by switching to renewable energy sources. #### 1 Double glazing

Double glazing is the term given to a system where two panes of glass are made up into a sealed unit. Replacing existing single-glazed windows with double glazing will improve comfort in the home by reducing draughts and cold spots near windows. Double-glazed windows may also reduce noise, improve security and combat problems with condensation. Building Regulations apply to this work, so either use a contractor who is registered with a competent persons scheme<sup>1</sup> or obtain advice from your local authority building control department.

### What can I do today?

Actions that will save money and reduce the impact of your home on the environment include:

- Ensure that you understand the dwelling and how its energy systems are intended to work so as to obtain the maximum benefit in terms of reducing energy use and CO<sub>2</sub> emissions.
- Check that your heating system thermostat is not set too high (in a home, 21°C in the living room is suggested) and use the timer to ensure you only heat the building when necessary.
- Make sure your hot water is not too hot - a cylinder thermostat need not normally be higher than 60°C.
- Turn off lights when not needed and do not leave appliances on standby. Remember not to leave chargers (e.g. for mobile phones) turned on when you are not using them.
- Close your curtains at night to reduce heat escaping through the windows.
- If you're not filling up the washing machine, tumble dryer or dishwasher, use the half-load or economy programme.
